 - d) You can only protest the following:

 - ii) Ineligible Pitcher
 - iii) Ineligible Player
 - e) Decals on Helmets will not be allowed at tournaments unless you have form from Manufacturer.
 - f) Patches are mandatory for all Tournaments.
